Assets are allocated among underlying Fidelity® funds according to a “neutral” asset allocation strategy of approximately 17 percent in domestic equity funds, 7 percent in international equity funds, 46 percent in bond funds and 30 percent in short-term funds. The investment objective of the Fidelity® VIP Freedom Income PortfolioSM is to seek high total return with a secondary objective of principal preservation. Fidelity Management & Research Company (FMR), is the fund's manager.

The Fidelity® VIP Freedom Income PortfolioSM is a series of the Fidelity® VIP Series. VIP portfolios are available for investment only by the separate accounts of insurance companies. VIP refers to Variable Insurance Products Fund. This is a moderately conservative investment.

Beta definition:

Beta provides a measure of a stock or fund's volatility relative to the market. The market is often defined by a certain benchmark, index or market average. The market's beta is 1. If a stock or fund is more volatile than the market, its beta will be higher than 1. If it is less volatile, the beta will be below 1. An investment that has a beta of 1.25 is believed to be more volatile than its market benchmark. For example, if the benchmark dropped 1 percent, then an investment with a beta of 1.25 is predicted to drop 1.25 percent. Remember, investment returns and principal value will fluctuate, so the value of your account, when redeemed, may be more or less than your original cost.
